This is to certify that Sainthia Nursing Institute, Vill- Daikota, P.O.-Deriapur, P.S.- Sainthia,, Dist-Birbhum, Pin-731243, West Bengal Under Trust Gitanjali Foundation New. is permitted to open GNM and B.Sc. Nursing course for Male from the Academic Session 2024-25 onwards instead of Female Students although the Institution have already been issued the Essentiality Certificate as per Memo No. No HNG/4T-12-2020/1092 Dated 04/08/2021 for Female Students with an annual intake of 60 (Sixty) students in each course, subject to the fulfillment of the following conditions:


1. **Obtaining approval of W.B.N.C., WBUHS & I.N.C within six (06) months after receiving the essentiality certificate**
2. **Arrangement of Affiliated Hospitals for all disciplines as per INC guideline before starting the course.**
3. **The Institute will be allowed to participate in the counseling process and to start admission only after getting NOC from WBNC, WBUHS & final approval from the INC.**
4. **Separate Class Rooms and Hostels with separate toilets facility for male and female students will be arranged.**

It is pertinent to mention here that the earlier Essentiality Certificate Vide Memo. No. HNG/4T-12-2020/1092 Dated 04/08/2021 was issued in favour of Sainthia Nursing Institute in respect of Female students only, as, at that time they prayed for such Essentiality Certificate only in connection with Female Students for G.N.M. & B.Sc. Nursing course both. But, as, now, Sainthia Nursing Institute has prayed for an Essentiality Certificate for imparting Nursing Training to Male Students only and not for Female students as expressed earlier, the instant Essentiality Certificate is issued as per their current prayer. This to further clarify that the presently studying Female students, shall be allowed to carry on their training course, along with the Male Students, to be admitted newly, and after the completion of the Training course of the said Female Students, no Female Student be admitted in the Sainthia Nursing Institute.

The Certificate will remain effective for three (03) years only provided that all the norms and conditions as per guidelines of the I.N.C., WBUHS and W.B.N.C. are maintained in the said institution.

So, the Essentiality Certificate issued in favour of Sainthia Nursing Institute as per Memo No. HNG/4T-12-2020/1092 Dated 04/08/2021 is hereby cancelled


